

Tender Notice

Sealed bids under two bid system (Technical and Financial) are invited from manufacture/ authorized dealer/distributor/supplier for supply and installation of the networking items indicated in Annexure-I for Network Control Centre to be set up at EAC to PM, Vigyan Bhawan, New Delhi.

2. The technical bid shall be submitted in a sealed envelope with signed copy of tender documents, along with all the requisite documents specified in Tender document. Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand Only) in the form of Account Payee Demand Draft/Pay Order/ Bankers Cheque drawn in favour of Pay and Account Officer, Planning Commission, payable at New Delhi must be submitted with Technical Bid. The financial bid in Performa at Annexure-I shall be filled up and kept in a separate envelop. Both these envelopes should be kept in an outer envelope super scribed with " Tender for Supply and Installation of Networking Items at EAC to PM, Vigyan Bhawan" and addressed to the Under Secretary (G-II), Planning Commission, Yojana Bhawan, Sansad Marg, New Delhi.
3. The last date of submission of bid is 19.09.2013 (upto 2.00 PM). The outer envelope containing technical and financial bids should be dropped in the tender box kept at the Reception Area, Yojana Bhawan within the period of 12.09.2013 at 9.00 a.m. to 19.09.2013 at 2.00 pm during office hours. Tender received after due date and time will not be accepted under any circumstances.
4. Complete Tender Document may either be downloaded from the website of the Planning Commission (www.planningcommission.gov.in) or CPP portal (www.eprocure.gov.in).
5. The technical bid shall be opened at 3.00 p.m. on 19.09.2013 in Room No. 412, Yojana Bhawan, Sansad Marg, New Delhi by a Tender Opening Committee constituted for this purpose in the presence of such tenders or their authorized representatives who may wish to be present. The Financial bid of only those tenderers, whose technical bids have been accepted, will be opened under intimation to the technically qualified bidders about the date, time and venue and in the presence of their authorized representatives (one per bidder) who may wish to be present.

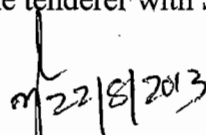

ANNEX-II

Specific Terms and Conditions

1. The representative of the participating firms/agencies/ suppliers may visit the location in EAC to PM, Hall-E, Vigyan Bhavan, New Delhi for inspection to installation of networking connections before quoting the bid.
2. The Technical bid must be accompanied with an Account Payee Demand Draft/ Pay Order/ Bankers Cheque of Rs. 10,000/- (Rupees Ten Thousand Only) as Earnest Money drawn in favour of Pay and Accounts Officer, Planning Commission and payable at New Delhi. Pay Order/Bank Draft/Bankers Cheque drawn in favor of any officer other than Pay and Accounts Officer, Planning Commission will not be accepted and the tender will be rejected.
3. Tender received after specified date and time will not be accepted. The earnest money of the unsuccessful tenderer will be refunded after finalization of the contract. No interest will be payable on the earnest money.
4. If any bidder withdrawn after submission of his/her bid, the EMD stands forfeited.
5. The bidders are advised in their own interest to quote their rates for all items in financial bid as per the specification indicate in Annex-I failing which their bids shall be out rightly rejected. Any overwriting/ corrections/ cuttings financial bid at Annex-I is not allowed and all such bid will summarily be rejected.
6. Validity of bid will be 180 days from the date of opening of financial bid.

Eligibility Criteria for Technical Bid

7. The Company/ Firm/ Agency shall submit following documents alongwith the Technical bid:
 - (i) Proof of office address, telephone number showing that the Company/ Firm/ Agency is registered and its branch office is located in Delhi/ NCR.
 - (ii) The Company/ Firm/ Agency should have its own Bank Account, TIN Number and PAN Card. Copies of letter, from bank stating that account is being maintained by the Company/ Firm/ Agency alongwith details like account number(s), TIN number and PAN Card.
 - (iii) The bidder Company/Firm/Agency must have minimum experience of three years to Centre Government Ministry/ Department/ Public Sector Undertaking/ Public Sector Banks in this field. Proof of experience certificated (at least two certificates during 2010-2012) may be enclosed with the Technical bid.

- (iv) An undertaking to the effect that the Company/ Firm/ Agency has ^{not} been blacklisted by any Ministry/ Department/ Organization of the Central Government/ State Government/ Public Sector Undertaking/ Autonomous Bodies etc.
- (v) EMD of Rs. 10,000/- (Ten Thousand only) in the form of Account Payee Demand Draft/ Pay Order in favour of Pay and Account Officer, Planning Commission and payable at New Delhi.
- (vi) Signed and stamped copy of the Tender documents.
- (vii) An under taking to the effect that the services of the Company/ Farm/ Agency were not terminated by the Planning Commission before the expiry of any contract made with the Firm.

Selection Criteria of Technical Bid

8. The Company/ Firm/ Agency must submit copies of documents mentioned in para 7 (i) to (vi) with Technical Bid. The bids received without these documents, i.e. 7 (i) to (vi) will be treated as non-responsive.
9. The Firms/ Contractors/ Suppliers/ anybody whose services were terminated by the Planning Commission before the expiry of the contract, are not eligible to participate in the bid for a period of 3 years from the date of termination of the contract.
10. The Technical bid shall be opened on the scheduled date and time (at 3.00 p.m. on 19.09.2013) in Room No. 412 Yojana Bhawan, New Delhi-110001 by the Tender Opening Committee in the presence of the representatives of the Company/ Firm/ Agency if they wish to present at the time of opening the Technical bid.

Selection Criteria of Financial Bid

11. Financial bid of only those bidders will be opened who qualify in Technical bid.
12. The L-I bidder will be selected from those technically qualified bidders whose total rate for all the networking items mentioned in financial bid and installation charges at Annexure-I, will be lowest.
13. The supplier shall provide free maintenance during period of warranty of networking items.
14. The successful bidder/ supplier (L-I) shall deposit a Performance Security Deposit amounting to 8% of the total value in the form of any Accounts Payee Demand Draft/ Fixed Deposit Receipt (FDR) in favor of Pay & Account Officer, Planning Commission, New Delhi or Bank Guarantee of commercial bank made in the name of the Agency and hypothecated to the Pay and Accounts Officer, Planning Commission, New Delhi covering the period of warranty after date of installation. The performance security shall remain valid for a period of sixty days beyond the date of the expiry of the contract.

General Terms and Conditions

15. In the event of failure to accept the Offer of work by the successful bidder for whatsoever reasons(s), Earnest Money Deposit submitted by the bidding Company/ Firm/ Agency shall be forfeited.
16. The selected bidder will be required to supply the material and install the same within 7 (seven) days of the award of the contract.
17. Planning Commission will make no advance payment. Payment will be made by Electronic Clearing System (ECS) after satisfactory completion of the work.
18. In case, the contractor shows its inability at any stage for whatsoever reason(s), the performance security deposit would be forfeited.
19. The Competent Authority in Planning Commission reserves the right to cancel the tender at any time/ stage or relax/ amend/ withdraw any of the terms and conditions contained in the Tender Documents without assigning any reason, thereof. Any inquiry after submission of the tender shall not be entertained.
20. Any controversy or dispute arising out of this contract shall be referred to the sole arbitration of the Head of the Department (HOD), Planning Commission, New Delhi or to any officer nominated by him. There shall be no bar to the reference of dispute to the arbitrator or such an officer as is nominated by the HOD even though the said officer is an employee of the Planning Commission, New Delhi might have dealt with the matter earlier or expressed his opinion thereon. In case the arbitrator, to whom the matter earlier is originally referred to, is transferee or vacates his office or is unable to act for any reasons, the HOD shall be entitled to proceed with the reference, from the stage at which it was left by his predecessor. No person other than the one nominated by the HOD shall act as arbitrator. The decision of the HOD or the officer nominated by him shall be final and binding on the party/ parties. The limitation for filing claim for arbitration is 90 days from the date of expiry of the contract period and in case no claim is filed within this period, it shall be presumed that there is no claim.
21. Subject to the above, the provisions of the Arbitration Act, 1996 or any statutory modification or enactment on enactment thereof and rules made there-under and for time being in force, shall apply to arbitration proceeding under this Clause.
22. The arbitrator may from time to time extend the time for making and publishing the award. He may do so without any need for obtaining the consent of the parties to dispute.
23. Any notice/ direction given to the Second Party under the terms of this agreement shall be considered to be duly served if the same have been delivered to, left for dispatched by Registered Post to the Second Party at his last known address. Any notice to be given to the
