
Terms and Conditions

1. The bidders may inspect the items on date and time indicated in the Auction Notice and satisfies themselves about the items they are bidding for.
2. Since it would be an open bid No Sealed Quotations will be accepted. Auction shall be made on 'as is where is basis'.
3. Auction will be carried out / sold out with full quantity of condemned material and not in pieces.
4. No items, once disposed to the selected bidder shall be taken back by Planning Commission under any circumstances whatsoever.
5. The selected bidder will be required to deposit at least 25% of the bid value on the day of auction by cash or Demand Draft \ Pay Order drawn in favour of 'The Pay and Accounts Officer, Planning Commission, New Delhi, payable at New Delhi issued by any Commercial Bank.
6. The selected bidder will make the balance payment of 75% in full, in the form of Demand Draft \ Pay Order in favour of "Pay and Accounts Officer, Planning Commission", within 5 days of bid awarded, failing which the offer will be cancelled and EMD shall stand forfeited.
7. The Selected bidder shall be required to lift all the items from the disposal site within 5 days after the payment of the full amount. On failure to do so, Planning Commission shall have the right to dispose the items to alternate bidder at the cost and risk of the selected bidder.
8. The Selected bidder should ensure himself that the whole auctioned lot is removed and in case any item left at site, the same shall be thrown away at the risk and cost of selected bidder. The bidder shall have no claim for the refund of his earnest money in the case.
