

Tender Notice

Sealed tenders in proforma at Annexure-I are invited from companies/ authorized dealers/distributers of Apple/Sony laptops for supply of 06 Apple MacBook Pro (13.3" entry level version with 2.4 GHz Intel Core i5 Processor, 4GB Ram, 500 GB SATA Hard Drive- with and without office for Mac) and 02 Sony Viao VPCSB (17GG/B, 13,3" version with 2.5 GHz Intel core i5 Processor, 4GB RAM, 500 GB SATA Hard Drive with windows 7 professional, 64 bit and MS Office 2007) for Office of Adviser to the Prime-Minister's National Council on Skill Development.

2. Tender shall be dropped in the Tender Box kept in the Reception Area, Yojana Bhavan, Parliament Street, New Delhi from 09.01.2012 to 12.01.2012 from 9.00 am to 5.30 PM and from 9.00 am to 3.00 PM on 13.01.2012. The tender will be opened on 13.01.2012 at 3.30 PM in Room No. 411, Yojana Bhavan, Parliament Street, New Delhi by tender evaluation committee constituted for this purpose in the presence of representatives of participating bidders who may wish to be present.

Terms and Conditions

3. The participating bidders are required to submit earnest money deposit of Rs.20000/- in the form of Accounts Payee Demand Draft/fixed deposit receipt/Bankers Cheque or Bank Guarantee from any commercial bank in favour of Pay and Accounts officer, Planning Commission, payable at New Delhi

4. EMD of un-successful bidder will be returned to them after placement of supply order. It will be returned to the successful bidder after supply and successful installation of laptops.

5. If the successful bidder declines to supply the laptops for whatsoever reason after finalization of bid, its EMD will be forfeited.

6. The suppliers shall provide maintenance free of cost during warranty period of laptops.

7. No bidder will be allowed to withdraw after submission of bids, otherwise the EMD will be forfeited.

8. Successful bidder will have to submit performance security deposit in the form of FDR in favour of Pay and Accounts Officer, Planning Commission @8% of the total purchase value including taxes. The date of validity of FDR should be 14 months from the date of probable delivery.

9. In case, the successful bidder fails to fulfill any contractual/warranty obligations, the performance security will be forfeited.

10. The supplier shall supply and install the laptops within 15 days of placement of supply order failing which EMD will be forfeited.

11. The supply order will be placed to the bidder whose total rate of 08 laptops (including taxes) will be lowest.

12. The participating bidders shall submit the signed and stamped copy of this terms and conditions along with the tender in token of acceptance of term and conditions


