Subject: Annual Plan 2007-08 - Approval regarding.

Sir.

I am directed to refer to the Government of Tamil Nadu's letter No. 9084/SP/2006 dated 26.07.2007 on the above subject and to convey the acceptance of Planning Commission to the outlay of Rs.14000.00 crores.

- 2. The amounts dealing with Flagship programmes and the corresponding state share that needs to be provided in the State Plans may be adequately arranged in the supplementary estimates so that the state may not lose the share of the central assistance for the Centrally Sponsored Schemes.
- 3. The outlay of Rs.1649.84 crores allocated/proposed by Tamil Nadu in the Annual Plan 2007-08 for SCSP and Rs.31.85 crores for TSP is not in conformity with the guidelines of Planning Commission on SCSP and TSP. The amount allocated in divisible schemes cannot be considered for the SCSP and TSP. Since the SC and ST population of the State of Tamil Nadu is 19% and 1% respectively, proportionate outlays may be provided in the Annual Plan also. As per the SC & ST population i.e. 20% in the State, the State Government should earmark an outlay of Rs. 2660.00 crore for SCSP and Rs. 140.00 crore for TSP for Annual Plan 2007-08 by the RE stage.
- 4. A Statement showing the distribution of Approved Plan outlay under different heads and sub-heads of development is enclosed. The earmarked outlays for different schemes have also been indicated therein. Approval is being given based on the assurance of the Principal Secretary Planning, Tamil Nadu, in letter No. 9084 dated 3.8.07 that the 'outlay for SCSP and TSP is likely to go up in the Annual Plan 2007-08 at the RE stage'.
- 5. Kindly acknowledge the receipt of this letter.
