Skill Development Initiative scheme of DGE&T based on Modular Employable Skills (MES):

Objectives:

- To provide vocational training to school leavers, existing workers, ITI's graduates etc.
- To improve their employability by optimally utilizing the infrastructure available in Govt./ Private institution and the Industry.
- Existing skills of the persons can also be tested and certified under this scheme.

Progress of the State Govt. of Haryana for implementing the SDI scheme

Achievements:

- Under SDI Scheme a total 75 Vocational Training Providers have been registered by the State and 23316 students have been trained under this scheme. Now the scheme has been on lined through SDIS Web Portal.
- 7 VTPs out of 75 VTPs have been successfully registered online and rest are under process for the same. Training activities have been started in 5 VTPs and the training batch has been approved online of 1 VTP.
- Presently 36 VTPs have been allowed to start the MES courses by VTP Evaluation Committee.
- 9 VTPs out of 36 for registration as VTP have been acknowledged successfully through SDIS Web Portal. Bank guaranty and undertaking is awaited.
- 3 new VTPs cases have been acknowledged after cross verifying the hard copy submitted by the applicant for registration of VTP.

Hurdles being faced while running the scheme online through SDIS Web Portal:

- ❖ 75 VTPs were registered in the State well before 1st January, 2012. The details of these institutes with sectors and modules are not available on site where as it should have been readily available on the SDIS Web Portal by DGE&T/RDAT.
- ❖ Many VTPs / Institutes are facing problems while uploading the informations on SDIS Web Portal as they are not well acquaintanted with the web portal. Workshops must be arranged in the state to address the problems being faced by VTPs and for updation of their knowledge.

❖ Main Features of a Typical ITI under PPP mode

- Training capacity - 200-250 students per shift
- Training in 4-5 employable trades
- 3-5 Acres of land by State Govt.
- Indicative cost - Rs.3.5 crores
- D.P.R is being prepared by G.O.I consultants

❖ Main features of a typical Skill Development Centres

- Training capacity - 300 students per shift, especially for service sectors.
- About 200-500 Sq. mts of land
- Indicative cost - Rs. 30 lakhs
- D.P.R is being prepared by G.O.I consultants

❖ Strategy

- State Govt. to provide free land.
- Building, Machinery and operational cost by Training provider
- Govt. of India to provide Viability Gap Funding (VGF).

ITIs to be set up in PPP mode

- Unserviced block in the State : 29
- Allocation of ITIs by GOI : 25
- Proposal sent to GOI : 13

SDCs to be set up in PPP mode

- Allocation of SDCs by GOI : 85
- Proposal sent to GOI : 96

✓ Feasibility study regarding setting up of ITIs/SDCs at Ambala has been carried out by 'Transaction Advisory Services Agency' appointed by DGE&T, GOI

At present, matter is under consideration with DGE&T, Govt. of India. No approval/status report/DPR for any of the above 13 ITIs has been received from DGE&T, GOI even after repeated reminders and D.O. letters by Director, Industrial Training Haryana.

Issues

- The Skill Gap Survey in the State of Haryana to be conducted by Government Institute, IAMR, New Delhi is under process for finalization
- Establishing SDCs in PPP mode alone will not serve the purpose. State Governments should also be invited to establish SDCs in high cost sectors like production, automobile, fabrication etc. in society mode. State Governments should be financed by Govt. of India for creation of infrastructure of such SDCs.
- Cost effective mechanism should be evolved for monitoring the functioning of VTPs to check bogus registration of students, bogus attendance, bogus training and bogus assessment etc.
- Assessment is the most crucial factor for the success of MES scheme. Assessing Centres should be fixed and they be made responsible for maintaining the records related to assessment of trainees. Govt. ITIs are the best options for assessment centres as they are already conducting trade examinations and having sufficient infrastructure for the same.
- Assessment should be thorough and should be based on practical examination of all the skill evolved in the MES module. Video Recording of the assessment must be carried out so that before declaration of the result / assessment of skills cross verification of genuineness of assessment can be verified.
